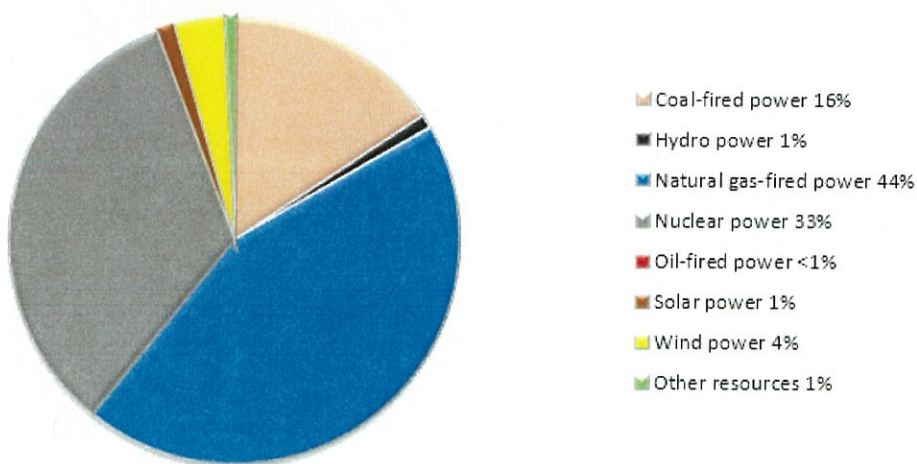
## Important Information about your Electricity Sources

As a certified Alternative Electricity Supplier, Just Energy Solutions Inc. ("Just Energy") is required to provide its customers with Environmental Disclosure Information quarterly under Section 16-127 of the Electric Service Customer Choice and Rate Relief Law of 1997 and the rule of the Illinois Commerce Commission, 83 Ill. Adm. Code 421.
